# Program could be a charter school

School leaders seem to have found a way to help fund the International Baccalaureate program they want to put at Green Run High: Make it a charter school.

The move could net federal charter school grants to supplement what the division would pay, they told the School Board on Tuesday. In a tough fiscal climate, they said, the \$600,000 could make a big difference.

Princess Anne High already has IB – a rigorous

program used in more than 140 countries. But, arguing there's enough demand for a second, the board this year allocated seed money to examine adding another. School officials estimated earlier this spring that an IB program like the one at Princess Anne could have operating costs of about \$720,000 a year.

Making the program a charter school – a school run privately with public money – would be an unusual step. Virginia has four, none in Hampton Roads. But it's not unprecedented, either. Jill Gaitens, grants coordinator for the division, said Fairfax

County is planning a similar charter.

Like that one, students in the proposed Green Run Collegiate Academy would be enrolled not only in IB, but also in Advancement Via Individual Determination, which gives middle-of-the-road students a boost with study and organization skills.

Pairing the two is key because students would be selected for the academy by a lottery; it's required by the federal grant program. AVID would help bring lower-achieving students up to the level they need for IB, Gaitens said.

Preliminary plans call for

the school to open in August 2013. It would likely be run by a nonprofit board, and details would be hammered out in the contract. But on Tuesday, not everyone seemed on board.

Brent McKenzie worried that using a lottery would make Green Run's program the "junior IB" compared with the one at Princess Anne. Board Chairman Dan Edwards countered that the program doesn't have to be an exact duplicate to be successful.
